I confirm that I accept the ATS Foundation Research Program grant under the following conditions:

1. The title of the grant is the ATS Foundation/Breathe California of LA Research Grant.
2. The grant is \$40,000 per year for two years.
3. The funding for each year is disbursed in two installments of \$20,000 (January and July).
4. The grant begins January 15, 2016 and ends on January 14, 2018.
5. The award will be used to support the proposed research for the project entitled *"Improving Pediatric Emergency Department Asthma Care: The ePACCI-ED Trial."*
6. Awardees are required to notify the ATS in writing in case of change of address, institution, position or status. Current contact information must be provided to the ATS immediately upon any changes.
7. If an awardee changes institutions, the awardee must obtain permission in writing from the ATS office in order to transfer the ATS Foundation Research Program grant.
8. Funding will be disbursed after awardees have submitted approved IRB and IACUC protocols, if applicable to the project, to the ATS office.
9. Awardees must be ATS members at the time of accepting the grant, and maintain that status throughout the term of the grant.
10. Awardees are required to inform the ATS of any awards received during the period of the ATS Foundation Research Program grant within 60 days of receiving the award or the notification for the award, as well as provide the "Specific Aims" pages of both the ATS award and the new award. The ATS does not allow continuation of an ATS Foundation Research Program grant at the same time as another research grant with budgetary or significant scientific overlap. The ATS Scientific Advisory Committee will adjudicate issues surrounding overlap.
11. Awardees are required to submit an interim progress report after the first year of support. The second year of funding is contingent on the demonstration of good scientific progress during year 1 of the award.
12. Awardees' institutions are required to submit an interim financial report after the first year of funding. The institution may also submit a request to have unused first year funds available for the second year of support.
13. Awardees are required to submit a final progress report 30 days from the end of the funding period.

14. Awardees' institutions are required to submit a final financial report 60 days from the end of the funding period.
15. Awardees must make proper written acknowledgments of the ATS Foundation Research Program and the Breathe California of LA on any publications describing research findings resulting from the grant.
16. PIs and grantee organizations are expected to make the results and accomplishments of their activities available to the research community and to the public at large. In addition, any inventions that result from these grant funds should be used in a manner that promotes free competition and enterprise without unduly encumbering future research and discovery.
17. The ATS Foundation Research Program and Breathe California of LA logos must be included in presentation materials that describe research supported by this award. High resolution images of these logos will be sent to you upon execution of this contract. Presentation materials include posters, abstracts, and media releases. When presenting the logo on posters, the logo must be **at least** 3.0 inches in width and 1.0 inch in height. "Exclusion zones" of white space must be used judiciously around the group of elements as well as between each element. Being consistent in assigning white space will help to maintain a professional look. A minimum of 1/4" white space all around is generally recommended.
18. Awardees will participate in an annual survey updating the ATS on their professional status, direct research dollars obtained since funding of the ATS award, and a list of publications citing the ATS Foundation award as a source of support. Other information, such as number of trainees mentored, may be requested as well.


